Expectations for inflation in 2000, measured by IGP-DI, reduced to 7.40% from 7.59%. For the IGP-M, the median reduced to 7.48% from 7.69%. Expectations of general price indices variation in 2001 remained at 5%. Forecasts for the trade balance surplus reduced to US\$ 3.3 billion in 2000, and to US\$ 5.25 billion in 2001, from US\$ 3.5 billion and US\$ 5.4 billion last week. For the current account, expectations are of a US\$ 23.3 billion deficit in 2000, reducing to US\$ 22.95 billion in 2001.




