

BANCO CENTRAL DO BRASIL – FOCUS

February 2, 2001

Median of market expectations for the consumer price index – IPCA remained stable at 4.20% for 2001 and at 0.23% for February 2001, as tracked by Banco Central do Brasil daily survey. Forecasts for the INPC increased to 4.06% from 4.00% for 2001 and to 3.57% from 3.50% for 2002. Forecasts for the IGP-DI remained stable at 5.10% for 2001 and 4.00% for 2002. Median of market expectations for the IGP-M were incremented to 0.27% from 0.25% for February 2001 and remained stable at 5.00% for the year 2001. Expectations for the trade balance deteriorated to US\$0.45 billion from US\$0.50 billion for 2001 and remained stable at US\$1.50 billion for 2002. Forecasts for the current account deficit improved to US\$26.10 billion from US\$26.12 billion for the year 2001 and remained stable at US\$25.10 billion for 2002. Forecasts for other economic indicators, along with median expectations for the Top 5 forecasters are quoted in the tables and figures below.

Explanatory Note

Top 5 median expectations indices are calculated from the full sample based on the five institutions with minima penalty scores, calculated from observations on the institution's degree of forecast precision over the last four months. Each inflation figure that is released creates two penalty scores for each institution, that are the quadratic errors of the forecasts that the institution informed two and one day before the release of the actual figure. If the institution did not inform any value for those days, it receives the penalty of the worst performer in the sample for the period. The monthly penalty is calculated according to the formula below.

$$\text{monthlypenalty} = \frac{(100 \cdot (E[\pi_t | t-2] - \pi_t))^2 + (100 \cdot (E[\pi_t | t-1] - \pi_t))^2}{1000}$$

where π denotes inflation in percentage points.

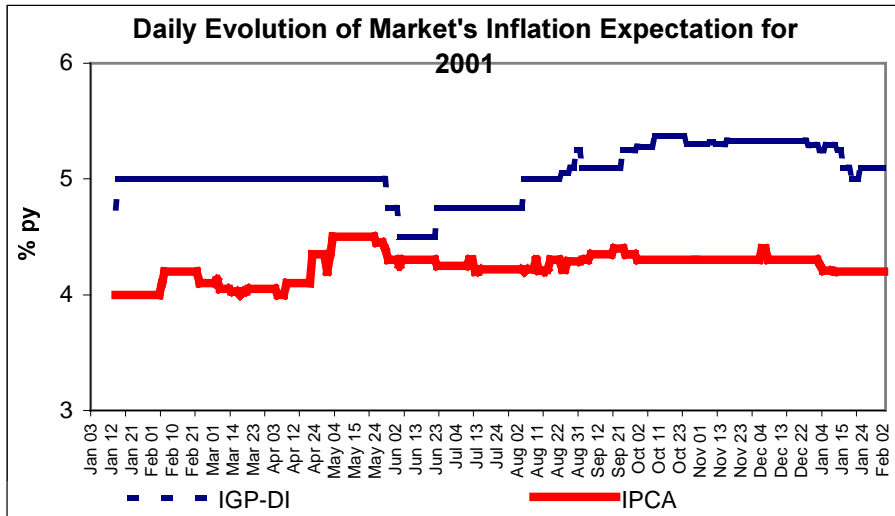
